Victoria Tauli-Corpuz is the UN Special Rapporteur on the Rights of Indigenous Peoples, and is an indigenous leader from the Kankana-ey Igorot people of the Cordillera Region in the Philippines. She is a social development consultant, indigenous activist, civic leader, human rights expert, public servant, and advocate for indigenous women's rights.

As a youth activist in the 1970s, she helped organize Indigenous Peoples in the Philippines to stop the Chico River Hydroelectric Dam and the Cellophil Resources Corporation. As an indigenous leader, she was actively engaged in the drafting and adoption of the UN Declaration on the Rights of Indigenous Peoples in 2007. She served as the Chair of the UN Permanent Forum on Indigenous Issues from 2005 to 2010.

In 2009, she received the Gabriela Silang Award from the National Commission on Indigenous Peoples in recognition of the work she has done at the forefront of the struggle for Indigenous Peoples' rights. She is also the founder of Tebtebba, the Indigenous People's International Centre for Policy Research and Education.

Myrna Cunnigham, a Miskita feminist and indigenous rights activist from Nicaragua. She served as the Chairperson of the United Nations Permanent Forum on Indigenous Issues until 2012. She is also the president of the Association for Women's Rights in Development (AWID) Board of Directors.

Dr. Myrna Cunningham of Nicaragua is a Miskito Indian and an important political leader of Indigenous Peoples in the Americas. Dr. Cunningham has worked over 30 years as a teacher and doctor in hospitals and health clinics throughout Nicaragua. She has worked at the local, national, and International levels to advocate for human rights, the collective rights of Indigenous Peoples, and women's health. For her activism, she has received several international awards. She is vice president and founding member of the Indigenous Initiative for Peace with Nobel Prize laureate Rigoberta Menchu, and member of the Board of Directors of the World Women's Fund.

Dr. Cunningham served as the Chairperson of the United Nations Permanent Forum on Indigenous Issues until 2012, and she is currently the president of the Association for Women's Rights in Development's (AWID) Board of Directors. She is also currently a member of the Board of The Hunger Project, and a Trust Fund for Indigenous People, Tropical Agricultural Research and Higher Education Center (CATIE), Indigenous Peoples Assistance Facility (IPAF). She is also First Vice President of the Board of the Fund for the Development of Indigenous People of Latin America and the Caribbean.

Cécile Ndjebet is the President of the African Women's Network for Community Management of Forests (REFACOF). She is the Executive Director of Cameroon Ecology, a national NGO based in Edéa, Cameroon, and the National Coordinator of Cameroon's civil society platform on REDD+ and Climate Change. For the past 18 years, Ms. Ndjebet has been devoted to women's rights issues. She holds a Master's in social forestry and is a gender specialist, providing training and advice in women's leadership. She is also a member of the Steering Committee of the Forests Dialogue, a focal point of the Women's Major Group of the United Nations Forest Forum (UNFF), and a representative of the Women of the Global South Group in the World Bank Forest Carbon Partnership Facility (FCPF).

Madhu Sarin has been working on forest tenure reform in India for the last 15 years. Sarin was a member of the Technical Support Group constituted by the Ministry of Tribal Affairs which drafted the Indian Forest Rights Act passed by Parliament in 2006. She has also an honorary Fellow of the Rights and Resources Initiative (RRI) based in Washington DC.

Rukka Sombolinggi is the first women Secretary General of Aliansi Masyarakat Adat Nusantara (or <u>AMAN</u>), an organization of indigenous peoples in Indonesia which as of today has 1,025 indigenous communities and more than 30 indigenous organizations as members. She belongs to the Toraya People in central part of Sulawesi Island.

She produced "Standing Strong on the Tsunami Ruins" in April 2005, a film documentary about Indigenous communities affected by Tsunami in Aceh. The film was funded and presented by AMAN and Assembly of First Nations (AFN Canada) before a side event during the 4th Session of the UN Permanent Forum on Indigenous Issues, 16-27 of May 2005 at the UN Headquarters in New York, USA.

Before joining AMAN in 1999, she worked for JAPHAMA (Jaringan Pembelaan Hak-hak Masyarakat Adat), a network of indigenous peoples' defenders — one of the main groups that convened the first congress of indigenous peoples in Indonesia in March 1999 during which AMAN was established.
