## Andy White—Coordinator, Rights and Resources Initiative

Prior to helping create and establish RRI, Andy served as Senior Director of Programs at Forest Trends and Natural Resource Management Specialist at the World Bank, as well as worked as a consultant to the International Food Policy Research Center, Save the Children Federation and the Inter-American Foundation. He has worked extensively in Haiti, Mexico and China and supervises policy research, advocacy and policy engagement Asia, Latin America and Africa. His research and publications have focused on forest tenure and policy, forest industry and trade, as well as the role of forests, communities and institutions in climate change. ### Luiz Carlos Joels – Brazilian Forestry Expert

Luiz Carlos Joels is an experienced forester and has a Ph.D. in geography. He has worked for over 30 years in the Brazilian Amazon on issues relating to forests, traditional communities, environment, rural development, science and technology. He was previously employed by the Amazonas State Agricultural Extension Company; the World Wildlife Fund; the Brazilian Institute for Research in the Amazon; Brazil's Ministry of the Environment and Ministry of Science and Technology; and the Brazilian Forest Service. Joels has also participated in National Councils on Environment, Forests, Biodiversity, Agenda 21 and Deforestation Control. He resides in Rio de Janeiro where he works as a private consultant and volunteers with Amazonian NGOs.

## Adriana Ramos – Vice Executive Secretary, Instituto Socioambiental (ISA)

Adriana Ramos is the Vice Executive Secretary of Instituto Socioambiental, a nonprofit that represents organizations working on indigenous rights issues in Brazil. For the last 20 years, she has been an active advocate for improving social and environmental sustainability through legislation and policies. She has also been executive secretary of the Sustainable Amazon Forum since 2010, and is Coordinator of a Brazilian NGO Forum working group on forests, and a civil society representative on the Amazon Fund Guidance Committee.

### Antônio Carlos Hummel – Director General, Brazilian Forest Service

Antônio Carlos Hummel works for the Brazilian Institute of Environment and Renewable Natural Resources (IBAMA). He has a degree in Forest Engineering with a specialization in Environmental Law, and Masters degree in Tropical Forests Science by the INPA (Amazon National Research Institute). Hummel has held many positions in the IBAMA and coordinated the Project for the Support of Sustainable Forest Management in Amazonia – ProManejo – PPG7, a widely recognized international cooperation project in the forest area. He has also served as a professor and has more than twenty articles published about forest issues. Hummel was the Director for Sustainable Use of Biodiversity and Forests of IBAMA for more than six years. During his administration several key instruments of forest management were consolidated, such as the creation of the Forest Origin Document – DOF, the organization of the "mahogany" exploitation in the country, and the consolidation of the legal framework for forest management in the Amazon. Hummel also has coordinated the process of decentralizing forest management to the state administrations. Since April 2009, Hummel has been the Director General of the Brazilian Forest Service, where he is responsible for the forest concession processes throughout Brazil, as well as the Forest Development agenda, which includes Sustainable Forest Management (including community-

#### Su Yufang - Deputy Director, Center for Mountain Ecosystem Studies

### Madhu Sarin – Fellow, Rights and Resources Initiative

Madhu Sarin, an RRI fellow, has worked on community based natural resource management for over 30 years. For the last 10 years, she has been actively involved in the movement for forest tenure reform in India, and has written extensively on these issues, with papers published in

She is an active member of the Campaign for Survival and Dignity which works to mobilize communities for claiming and asserting their rights under the FRA. In addition to being on the governing board of several NGOs in India, such as Vikram Sarabai Centre for Development Interaction (VIKSAT), Aga Khan Rural Support Programme (AKRSP), and Sutra, Madhu serves on the boards of Regional Community Forestry Training Center (Bangkok) and International Institute for Environment and Development (IIED), UK.

### Sudhansu Sekhar Deo – Indian Expert in Natural Resource Management

Sudhansu Sekhar Deo is a Postgraduate in Botany with 14 years of experience in the field of natural resource management. He has worked directly with communities within the Similipal Biosphere reserve for protection of their rights over the natural resources in the biosphere, promoting village networks and providing research on various laws and policies and the strengthening of local resource based livelihood to reduce pressure on the biodiversity of Similipal. Sudhansu is associated with different right based groups in India in the field of forest management, genetic resource conservation, agriculture, water and sanitation. His current position with Vasundhara involves research and advocacy on the governance and management of forests in the post FRA-2006 scenario and assessment of impact of different forestry programs of government on community forest management.

### Tushar Dash - Director Forest Rights Act Thematic Group, Vasundhara

Tushar currently leads the thematic group in Vasundhara on Forest Rights Act which focuses on research and advocacy on the process of implementation of India's Forest Rights Act (FRA) in the state of Odisha among other states. His research and work areas include issues in the implementation of FRA, mainly on habitat rights of Particularly Vulnerable Tribal Groups (PTGs), displaced communities and other traditional forest dwellers; rights of shifting cultivators; seasonal access rights of nomadic and pastoralist communities; diversion of forest land; forest village conversion and community forest management after recognition of rights. Tushar is also coordinating a national level learning and advocacy group on community forest rights in collaboration with Kalpavriksh. He has led many guiding, training and capacity building programs on the Forest Rights Act.
